NOTICE OF INTENTION TO DISTRIBUTE ASSETS OF THE PRIMARY ESTATE OF A MULTI-GENERATIONAL ESTATE PURSUANT TO THE ADMINISTRATOR-GENERAL'S (AMENDMENT) ACT
