THE ADMINISTRATOR GENERAL'S ACT

THE ADMINISTRATOR GENERAL'S (FEES) (AMENDMENT) REGULATIONS, 2004

In exercise of the power conferred on the Minister by section 60 of the Administrator General's Act, the following Regulations are hereby made:—

- 1. These Regulations may be cited as the Administrator General's (Fees) (Amendment) Regulations, 2004 and shall be read and construed as one with the Administrator General's (Fees) Regulations, 1999 (hereinafter referred to as the principal Regulations) and all amendments thereto.
- 2. The principal Regulations are hereby amended by deleting the Schedule thereto and substituting therefor the following:—
